

OFFICIAL RULES – Nationwide® Ultimate Zoo Experience Sweepstakes

These are the Official Rules of the Nationwide Ultimate Zoo Experience Sweepstakes (“Sweepstakes”). The Sweepstakes is sponsored by Nationwide Mutual Insurance Company (“Nationwide”), One Nationwide Plaza, Columbus, Ohio 43215.

NO PURCHASE IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. MAKING A PURCHASE WILL NOT INCREASE THE ODDS OF WINNING.

ELIGIBILITY

This Sweepstakes is open to legal residents of the fifty United States and the District of Columbia, except where prohibited and as noted below, who: (a) are 18 years of age or have reached the age of majority in their jurisdiction of residence at the time of entry, whichever is greater, and (b) are legally able to work in the United States. **No purchase is necessary. Not available to residents of Georgia, Maine, and New Hampshire.**

HOW TO ENTER

The Sweepstakes will run from August 1, 2019 to December 31, 2019 (Sweepstakes Period).

To enter complete one of the following options:

1. You must provide your email address and complete the quote process to be eligible to enter. Limit one (1) entry per person per day.
2. Visit <http://www.petinsurance.com/JungleCats> during the Sweepstakes period and send our Jungle Cats E-Card to a friend. You must provide your email address and your friend’s email address to be eligible to

enter. Limit one (1) entry per person per friend’s email address.

3. **ALTERNATE METHOD OF ENTRY:** You may enter by filling out an online entry form found at www.petinsurance.com/alternateentry. You must provide a valid email address and state of residency. No purchase necessary. Limit one entry per person per day.

All entries in the Prize drawing have an equal chance of winning. Odds of winning a prize depend on the number of eligible entries received during the Sweepstakes Period.

Entry constitutes consent to participate in Sweepstakes and for Nationwide to obtain, use, and transfer the entrant’s name, address and other details for Sweepstakes administration purposes. DRAWING

At the end of each month, during the Sweepstakes Period, one (1) winner will be selected. The drawing will be held on or about the 15th day of the following month. A total of five (5) Monthly Prizes will be awarded during the Sweepstakes Period. Limit one (1) Monthly Prize per person during the Sweepstakes Period. Winners will be chosen from all the eligible entrants through random drawings. Winners will be notified via telephone or e-mail within 30 days of each monthly drawing.

One (1) Grand Prize (as defined under “Prizes”) winner will be selected during the Sweepstakes Period. The Grand Prize Winner will be chosen from all eligible entrants through a random drawing. The Winner will be notified via telephone or e-mail by 02/20/2020.

If a Prize winner is not eligible to win, or if Nationwide is unable to contact the winner after a reasonable effort,

the prize will be forfeited, and an alternate winner may be selected. Odds of winning depend on number of eligible entries received.

PRIZES

There will be one (1) grand prize and five (5) monthly prizes awarded during the Sweepstakes Period.

The grand prize consists of four (4) round trip coach airline tickets for four (4) people to Columbus, Ohio; a suite at the Embassy Suites by Hilton, Dublin Ohio for 3 nights; round trip ground transportation for four (4) people to and from John Glenn Columbus International airport to hotel; and four (4) entry tickets and a behind-the-scenes private tour of the Columbus Zoo and Aquarium. Additionally, the grand prize winner will receive four (4) Open-air Safari tickets to The Wilds animal safari park, four (4) entry tickets to Zoombezi Bay water park, and one \$500 Visa gift card (collectively the "Grand Prize"). Winner is responsible for all additional transportation and all other expenses not listed above.

The monthly prize consists of one collapsible jungle cat climber (the "Monthly Prize").

The Grand Prize travel package must be booked in the spring of 2020 for travel dates between May 22, 2020 through June 30, 2020.
